1.	The total number of section of the school shall be restricted to 29 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.

6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

The number of sections shall be restricted in accordance with 'H' above with land requirement unit scaled down to 2000 square meters i.e. 12 sections for every 2000 square meter additional land.

The total number of sections taken together for classes XI and XII should not be more than 1/3 of optimum number of section allowed on the basis of land holding for any school.

The number of sections and students shall be restricted as per the actual facilities in the school.

For class rooms of size less than 500 sq feet the enrolment shall be 0.08 X size of class rooms in sq feet

2.	Compliance of the points no. 1 to 6 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.
Sl. No.	CONDITIONS FOR COMPLIANCE
1	The total number of section of the school shall be restricted to 29 as per number of sections reported at the time of inspection. The total number of sections taken together for classes XI and XII should not be more than 1/3 of total number of section allowed. Further, increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft. The number of students in sections < 500ft shall be restricted to 32 as per bye laws.
2	As per IC report, the school is having CWSN toilet two each for boys and girls but not seen in the videography. The school does not have ramp/lift to access upper floor. The school is directed to construct ramp or install lift as declared in reupload section that in future it will be installed. Hence the school must ensure the provision for CWSN such as ramp at the entrance, ramp / lift to access upper floors and separate CWSN toilets for girls and boys on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD act and guidelines issued by the Board and submit compliance within 3 months on SARAS. Failure to submit compliance within the stipulated time shall invite financial penalty against the school.
3	The school shall conduct training of its teachers with CoE Pune within next 3 months and submit the compliance.
4	The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.
5	The school shall get all the mandatory certificates renewed periodically.
6	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
